## **Eligibility for participation in the Tool Rebel Junior Academy**

### **Who can participate?**

Young people between 12 and 24 can apply. The cut-off date for this age is 31 December of the application year. Participants can be individuals or groups.  
You can select the ideas - no topics are precluded.

### **How do I sign up?**

You can register on the Internet at <https://www-de.wera.de/en/>. For minors, the legal guardians must agree to your participation.  
There is no registration deadline. The cut-off dates for the quarterly scholarships are the following: 31/3, 30/6, 30/9, 31/12.

### **What is required for the application?**

All applicants are requested to upload a summary of their project on <https://www.wera.de>. Including contact details. For submission as a minor, a parental authorization of the parent or guardian with the application must be uploaded.  
The summary should be at least two pages of A4 and should not exceed 10 pages of A4. The font size must be at least 10 points of a standard font (e.g. Arial or Times New Roman) and the margins at least 2.5 cm left, right and above and 2 cm below. All sources used, as well as all supporting evidence, including a brief description of each support, must be provided.

### **How is the scholarship awarded?**

The projects are the subject to a selection process of Wera Werkzeuge GmbH and Junior Uni Wuppertal, who decides on the award of the scholarship. The decision of the jury cannot be revised, legal recourse is excluded.

### **Do I forgo rights to my work by participating?**

Expressly not! The rights remain entirely with the applicant.  
Expressly not! The rights remain entirely with the applicant. Wera may publish the project of the respective quarterly scholarship without stating the winners' names.

### **What else to consider?**

For all activities, the corresponding safety regulations must be observed. In particular, projects which endanger or discriminate against participants or third parties are excluded from the competition. These include in principle: experiments with explosives, drugs or radioactive substances, as well as experiments on yourself. In addition, work that promotes violence, develops or enhances weapons, uses or explores military technology, involves a risk of injury to participants or third parties, is not permitted. Participation in the application process must not violate applicable law.
